SCOPE OF WORK:

This request is to perform required grounds maintenance services on a weekly basis (billed per calendar month), at all of the listed complexes in this request. Weekly service includes all care of lawn and shrub areas, fertilizing, weeding, edging, pruning, cleaning sidewalks, parking lots and spaces, bike lanes, leaf pickup, minor litter pick up, and disposal of all work debris.


Awarded contractors must be prepared to offer complete service at each visit which includes not only mowing and trimming, but also keeping shrub beds weed free, removing suckers, low hanging limbs, smaller shrubs constantly trimmed as applicable to each site including around signs. Keeping parking lots weed free and moss free.

➤ All standard service is expected to be completed at each visit except for specific seasonal work.

MINIMUM WAGE REQUIREMENT:

There will be applicable Minimum <u>Wage Rates for sites numbered 1 through 7</u> as listed above that are established by HUD Department of Labor Relations for all services performed under this contract. There will be <u>no minimum wage rates required for numbers 8 through 11</u> as listed above.


