### LOWER INCOME RENTAL HOUSING FOR ELDERLY/DISABLED

The apartment complexes listed below may or may not be owned or managed by the Housing Agency, but offer some units that are subsidized (rent amount is reduced).

#### FOR INFORMATION ABOUT VACANCIES, CALL THE APARTMENT MANAGERS DIRECTLY.

Each manager keeps a waiting list for his/her own apartment building. Managers' phone numbers may change without notice.

Rent and utility costs vary from one complex to another. Some managers ask the applicant to pay 30 percent of his/her monthly income towards rent and utilities. Others ask the applicant to pay a flat rate which is determined by size of the apartment. When inquiring about vacancies, you may want to ask how rent is determined.
