The apartment complexes listed below may or may not be owned or managed by the Housing Agency. Some offer units where the rent amount is based on your income. Other complexes offer units at a fixed, reduced rate that is lower than the current market rent.

FOR INFORMATION ABOUT VACANCIES, CALL THE APARTMENT MANAGERS DIRECTLY.

Each manager keeps a waiting list for his/her own apartment building. Managers' phone numbers may change without notice.

Please keep in mind that the rent and utility costs will vary from one complex to another. Some managers ask the applicant to pay 30 percent of his/her monthly income towards rent and utilities. Others ask the applicant to pay a flat rate which is determined by the size of the apartment. When inquiring about vacancies, you may want to ask how the rent is determined.
