

# MARCH 15TH RESIDENT UPDATE

## COVID-19 & Vaccine Updates



- Effective March 12th, Lane County has moved to the "**Moderate Risk**" category which is super exciting! This new designation will allow business to increase capacity, expand available services and also increases the number of people that can safely gather together. Based on the "Moderate Risk" level, Homes for Good will be making the following changes to operations:
  - Site offices will reopen for scheduled appointments only.
  - Maintenance will begin to reschedule Preventative Maintenance Inspections and will process all routine work requests. Maintenance will continue to follow COVID-19 precautions.
  - Community Rooms will reopen with limited capacity and some resident programming may shift to in person service.
- Lane County continues with their efforts to vaccinate eligible members of our community and many more people will become eligible on March 29th when Oregon moves to Group 6. **Starting March 29, 2021 the following categories will become eligible to receive the vaccine:**
  - Adults 45–64 with one or more underlying health conditions with increased risk
  - Migrant and seasonal farm workers, Seafood and agricultural workers, Food processing workers
  - People living in low-income senior housing, senior congregate and independent living
  - People experiencing homelessness, people displaced by wildfires and wildland firefighters

- Lane County will be reopening applications for their **rent assistance** program on Friday, March 19th from 7:00am to 1:00pm. These funds are for Lane County renters with household income below 80% of Area Median Income who have experienced financial hardship because of COVID-19. - Congress just passed the American Rescue Plan. This plan includes another round of **individual relief payments** of up to \$1,400 per person, additional Unemployment Insurance, increases to the Child Tax Credit and funding for local government COVID-19 response. A reminder that relief payments are not counted as income for the purposes of your rent calculation and do not need to be reported to Homes for Good.
