

### WHAT WAITLIST SHOULD I JOIN? THINGS TO CONSIDER

#### **OCCUPANCY**

Occupancy Standards means how many people qualify to be in the home. Occupancy Standards can be confusing. It is the number one reason applicants do not qualify for subsidy when they come to the top of a waiting list. At Homes for Good, we often go through 50 applications to find 1 application that meets occupancy standards. This takes time and slows down our ability to house applicants. It is important to understand what homes your family qualifies for.

Head of household and spouse or co-head = 1 bedroom

All other people = 2 per bedroom. The gender or age does not matter.

Head of household and 1 more person (child or adult) = 2 bedroom

#### What is the difference between a co-head and other adult?

A co-head is an equivalent of a spouse or partner. An "other adult" is any other adult in the household. For example, an aunt or adult cousin, etc.

Example #1: Husband, wife, daughter and son. Qualify for a 2 bedroom home.

Example #2: Boyfriend, girlfriend, daughter and girlfriend's Aunt. Qualify for a 2 bedroom home.

Example #3: Wife, wife, daughter, daughter, Wife's Aunt. Qualify for a 3 bedroom home.

Example #4: Nephew, aunt, cousin, cousin. Qualify for a 3 bedroom home.

Example #5: Father, aunt, daughter, daughter. Qualify for a 3 bedroom home.

With a Housing Choice Voucher, you can apply with any size family.

For all other waiting lists it is important to make sure you are applying to the correct waiting list based on your family size.

#### LOCATION

If you get to the top of a waitlist for a Tenant Based voucher (such as Section 8) you can use your voucher to live anywhere in Lane County. Project Based Vouchers (PBV) are for housing in a specific housing complex, as are Public Housing (PH), Multifamily Housing (MFH) or Affordable Housing (AH). It is recommended that you apply for waitlists for homes that are right for your family in the area you wish to live.

#### **INCOME LIMITS**

Income will not be screened when applying to the waitlist. However, income will be screened for eligibility if your waitlist number reaches the top of the list.

# Housing Choice Voucher (HCV)



#### **Program Description**

In the Housing Choice Voucher Program, often known as "Section 8", Homes for Good provides rental assistance to families to rent a home through the private rental market. With this Tenant Based subsidy Homes for Good forms a connection between families and landlords. With a Housing Choice Voucher, families may find secure, quality housing in neighborhoods of their choice.

#### **Subsidy**

As a tenant, you may initially pay up to 40% of your adjusted monthly income for rent and utilities. Homes for Good will pay the landlord the difference between the tenant contribution and the full rental cost. After the initial lease term, you could pay more than 40% of your adjusted monthly income towards rent & utilities.

#### **Income Requirements**

At or below Very Low-Income (50% Area Median Income)

#### **Occupancy Standards**

The head of household, including the spouse or cohead, will be allocated one bedroom. All other household members will be based on two (2) persons per bedroom, without regard to gender or age.

#### **Vacancy Information**

Admission to the Housing Choice Voucher program is dependent upon voucher availability.

#### Other Important Information

You are responsible for finding your own home.

# HCV (Section 8) Waitlist FAQs



#### Question 1: Is the waitlist first come, first served?

No, the HCV is not first come, first served. Referrals from Local Preference Partners will be served first. If you believe you qualify for a referral, you can go to: <a href="https://www.homesforgood.org/find-a-home/eligibility-and-applications/local-preferences">https://www.homesforgood.org/find-a-home/eligibility-and-applications/local-preferences</a>. All applicants will have an equal chance of getting on the waitlist, based on randomly assigned numbers. Those with the lowest randomly assigned numbers will be selected for the waitlist and served in order.

#### Question 2: If I get on the waitlist, when will I receive my voucher?

In October 2022 you will receive notification by USPS of whether you were placed on the waitlist or not. If you were selected to be placed on the waitlist, you will be sent an official application to determine your eligibility when your random selection number arrives at the top of the waitlist. This process can take anywhere from one month to two years depending on your number. We encourage you to begin compiling necessary documentation upon receiving a number.

#### Question 3: How do I check the status of my application?

After successfully completing your application online, there will be a receipt confirming the application went through. We recommend that you save a copy of this receipt for your records. While everyone will not get a place on the waitlist, everyone will receive a mailed letter notifying them of their application status in October 2022. # Project Based Voucher (PBV)



#### **Program Description**

A Project Based Voucher (PBV) is a type of Rental Assistance tied to a specific unit. The tenant does not have to search for a suitable unit.

#### Subsidy

The voucher subsidy is set so you will pay 30% of your adjusted monthly income for rent and utilities. Homes for Good will pay the landlord the difference between the tenant contribution and the full rental cost.

#### **Income Requirements**

For Ketanji Court only, income requirements are set at Extremely Low Income. All other PBV homes are set at or below Very Low-Income, 50% Area Median Income.

#### **Occupancy Standards**

The head of household, including the spouse or cohead, will be allocated one bedroom. All other household members will be based on two (2) persons per bedroom, without regard to gender or age.

#### **Vacancy Information**

Admission to a Project Based Voucher program depends on vacancies. Learn more about factors that affect wait time here: homesforgood.org/find-a-home/housing-details/wait-time-information

#### **Other Important Information**

After living in a Project Based Voucher subsidized unit for 12 months, you can apply to have your subsidy converted to a Housing Choice Voucher, also known as a Section 8 Voucher, and move to a dwelling of your choice.

Applicants who apply for the waitlist will receive a randomly assigned number. Those with the lowest randomly assigned numbers will be served next. The Commons on MLK, The Keystone and The Nel are accessed through Coordinated Entry. In Lane County, our Coordinated Entry System is a community coordinated response to homelessness that allows households to receive a standard, "Front Door" assessment to be added to a Central Waitlist for various housing programs. #### Subsidy

The subsidy is set so you will pay 30% of your adjusted monthly income for rent and utilities. Homes for Good will pay the landlord the difference between the tenant contribution and the full rental cost.

#### **Income Requirements**

At or below Low-Income, 80% Area Median Income.

#### **Occupancy Standards**

The head of household, including the spouse or cohead, will be allocated one bedroom. All other household members will be based on two (2) persons per bedroom, without regard to gender or age.

#### **Vacancy Information**

#### Question 2: After I apply, when can I move in?

#### Question 3: How do I check the status of my application?

After successfully completing your application online, there will be a receipt confirming the application went through. We recommend that you save a copy of this receipt for your records. When you reach the top of the waitlist you will get a letter in the mail from Homes for Good.

#### Question 4: What are the income limits?

At or below 80% Area Median Income.

# Question 5: What is the definition of "elderly or disabled" to qualify for homes that are reserved for elderly and disabled people?

Elderly is age 62 or older. Disabled means that a person meets the Social Security definition of a disabled person and is receiving SSI or SSD, or can provide documentation from a qualified professional verifying that he or she meets the definition of a disabled person, according to the Social Security Administration.

# Multifamily Housing (MFH)



#### **Program Description**

Multifamily Housing is a type of Rental Assistance tied to a specific unit. The tenant does not have to search for a suitable unit.

#### Subsidy

As a tenant, you will pay 30% of your adjusted monthly income for rent and utilities. Homes for Good will pay the landlord the difference between the tenant contribution and the full rental cost.

#### **Income Requirements**

At or below Very Low-Income (50% Area Media Income).

#### **Occupancy Standards**

Homes for Good will reference the following standards in determining the appropriate bedroom size:

#### **Program Description**

Affordable Housing has a fixed rent tied to a specific home. The tenant does not have to search for a suitable unit.

#### **Subsidy**

Affordable Housing homes do not have a subsidy associated with them. Residents are responsible for paying the full contract rent. Residents are able to use a Tenant Based voucher such as a Section 8 voucher in these units.

#### **Income Requirements**

At or below Low-Income (80% Area Media Income), and income must be twice the contract rent OR you must have a Tenant Based Voucher.

#### **Occupancy Standards**

Homes for Good will reference the following standards in determining the appropriate unit bedroom size:

For Village Oaks, the application is first come first served in order of date and time the application is received. For Firwood and Legion, applicants who apply for the waitlist will receive a randomly assigned number. Those with the lowest randomly assigned numbers will be served next.

#### Question 2: After I apply, when can I move in?

#### Question 3: How do I check the status of my application?
